SCHEDULE FOR REVISION OF THE 303-K RADIOACTIVE MIXED WASTE STORAGE FACILITY CLOSURE PLAN (S-3-1) AND THE 304 CONCRETION FACILITY CLOSURE PLAN (TS-3-2)

In a letter dated July 28, 1993, S. E. McKinney, Ecology, to R. N. Krekel, RL, 30182 "Revision of the 304 Concretion Facility and 303-K Mixed Waste Storage Facility Closure Plans (M-20-13 and M-20-15)," the State of Washington Department of Ecology (Ecology) proposed that the closure plans for the 304 Concretion Facility and 303-K Mixed Waste Storage Facility be revised. By mutual agreement between Ecology and the U.S. Department of Energy, Richland Operations Office (RL), work on the closure plans was put on hold until issues surrounding the appropriate closure standards could be resolved. Ecology now appears to be near completion on new closure standards for dangerous waste management units. Therefore, during the July 28, 1993, Unit Managers Meeting, RL agreed to commence work on Revision 2 to the 303-K Radioactive Mixed Waste Storage Facility Closure Plan (S-3-1) and Revision 2 to the 304 Concretion Facility Closure Plan (TS-3-2).

The following dates are proposed for the submittal of the revised Closure Plans: Revision 2 of the 304 Closure Plan will be completed by November 30, 1993, and Revision 2 of the 303-K Closure Plan will be completed by December 15, 1993.
