

PUREX AMENDED ADMINISTRATIVE ORDER NUMBER 15419 – CORRECTIVE ACTION 3, DRAFT PERMIT MODIFICATION

The Amended Administrative Order Docket #15419 for the Hanford Site, EPA/State ID # WA7890008967, dated September 14, 2017, established three corrective actions in response to the May 9, 2017, subsidence/partial collapse observed on the south side of PUREX Storage Tunnel 1 located in the 200 East Area of the Hanford Site. Corrective Action 3 consists of the following requirement:

By December 8, 2017, submit a draft permit modification to the Hanford Facility Resource Conservation and Recovery Act Permit, Dangerous Waste Portion Revision 8C to modify the permit to do the following:

- Update Preparedness and Prevention Addendum to ensure the control and mitigation of run-on onto PUREX Storage Tunnels 1 and 2.
- Update Process Information Addendum to include information required under Corrective Action 2 to demonstrate the ongoing ability of PUREX Storage Tunnels 1 and Tunnel 2 to continue to safely store mixed waste until closure. This includes submitting as a part of the modification, the structural integrity evaluation supporting safe operation of PUREX Storage Tunnels 1 and 2.
- Update the Closure Addendum to include any interim actions needed for safe storage of waste in PUREX Storage Tunnels 1 and 2.
- Update the Closure Addendum to address final closure under the Dangerous Waste Regulations coordinated with the future Comprehensive Environmental Response, Compensation, and Liability Act remedial decisions for both PUREX Storage Tunnels 1 and 2.


