Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The November 17, 1993 and December 15, 1993 meeting minutes not signed since this meeting was held via telephone conference call.

RL (R. N. Krekel)/WHC (F. A. Ruck) asked that Ecology (S. E. McKinney) sign the November 1993, December 1993, and January 1994 meeting minutes. The copies of the minutes for signature will be mailed over to Lacey after all comments are incorporated. Ecology could then sign them and mail them back to RL. Ecology indicated that this was acceptable.

2. Status Action Items

- 9-23-93:1

This action remains open. The DQO meeting will not be scheduled until Ecology's reorganization is completed and a new Unit Manager assigned.

- 11-17-93:1

This action remains open. One drum requires a new Storage/Disposal Approval Record (SDAR) since it has a radioactive 'hot spot' of about 0.7 mrem/hr. The SDAR originally prepared had a maximum 'hot spot' value of 0.5 mrem/hr.

3. Status Closure Activities

- Part A Permit Revision

The Part A Permit Revision has been completed was included in the closure plans sent to Ecology on December 17, 1993.

- Status of Closure Plan Revision 2

Revision 2 has been completed and was transmitted to Ecology on December 17, 1993. RL (R. N. Krekel)/WHC (J. G. Adler) asked if

Ecology had received their copy yet. Ecology (S. E. McKinney) indicated that he has received it.

**- Status of Ecology's Review of Closure Plan Revision 2**

Ecology (S. E. McKinney) discussed with RL (R. N. Krekel)/WHC (F. A. Ruck, E. A. Weakley, and J. G. Adler) the status of the Ecology review of the closure plan. The following points were discussed:

- The Ecology Unit Manager responsibility for the 303-K Storage Facility Closure Plan would be transferred from S. E. McKinney in the Lacey Office to an as yet undetermined person in the Kennewick Office. Ecology recommended that RL and WHC (F. A. Ruck) raise any concerns to the Ecology Kennewick Office very soon. RL/WHC indicated that a meeting had already been scheduled with the Ecology Kennewick RCRA Permit Supervisor for Friday, January 14, 1994.
- The review of the 303-K Storage Facility Closure Plan, Rev. 2, will not be finalized prior to it being transferred to the Kennewick Office. It will be the responsibility of the new Unit Manager to review the closure plan and determine if it meets Ecology's requirements.
- Ecology stated that two concerns about the contents of the closure plan that will be transmitted to the Kennewick Office.
  - The deferral of cleaning-up the soil associated with the 303-K Storage Facility to the clean-up of the 300 Area CERCLA operable units is unacceptable with the Lacey Office. Ecology commented that this was a change in position from when the RL/WHC were directed to revise the closure plan. WHC (F. A. Ruck) stated that RL/WHC understood Ecology's concerns, that RL/WHC still considers deferral of soil clean-up to be appropriate, and will be ready to discuss the concern with the new Kennewick Unit Manager
  - Ecology does not agree with the use of the Hanford Site Risk Assessment Methodology (HSRAM) in place of the methodology used by the Model Toxics Control Act (MTCA). Specifically, the concern is that the pending regulations require the use of MTCA methodology, not HSRAM methodology. WHC stated that the basic methodology is similar and that RL/WHC understood the need to discuss this concern with the new Kennewick Unit Manager.

**4. New Business**

None.

**5. Set Next Meeting Date**

Due to the transfer of the 303-K Storage Facility Closure Plan to a new, undetermined Unit Manager in Ecology's Kennewick Office, the next meeting was not scheduled.
