1. Approval of Past UMM Minutes

2. Status Closure Activities

- Response to Ecology's NOD's

Ecology (Mr. S.E. McKinney) informally transmitted a Notice of Deficiency (NOD) List.

- Lithium Concentrations

After reviewing the cleanup standard table and speaking with toxicologists in Ecology, Scott McKinney decided that a further investigation of the toxicity of Lithium will be required in order to establish cleanup concentrations. The available information does not provide a reference dose necessary for calculation via MTCA or HSB RAM. It was suggested that Westinghouse obtain toxicology studies.

3. New Business

Action Item:

- 11-17-93:1 A table comparing cleanup standards for 105-DR LSFF was provided to Ecology and DOE. The table calculated concentrations using both the MTCA and HSB RAM methodologies.
