Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The April 1994 Unit Managers' Meeting (UMM) minutes were signed by the Ecology Unit Manager (R. E. Cordts) and the Contractor Representative (F. A. Ruck) on April 12, 1994. The RL Unit Manager was not present and has not yet signed the minutes.

2. Status Prior Action Items:

- 5-04-93:1 WHC and RL will submit a petition requesting approval of the sonification procedure for the determination of volatile organics in concrete by following the guidelines in WAC 173-303-110(5).

WHC (A. L. Prignano) reported that the sonification petition has been completed and was transmitted to RL on April 11, 1994 for submittal to Ecology. Ecology (R. E. Cordts) has not yet received the petition.

3. Status Closure Activities

WHC (A. L. Prignano) stated WHC sampled the concrete at the 300 ASE on Wednesday and Thursday, April 27 and 28, 1994. Cores were taken at five sample sites. Samples for organic analyses have been submitted to Dr. Steve Metcalf of the WHC laboratories. Dr. Metcalf expects to have the analyses complete by May 11, 1994.

WHC (A. L. Prignano) also reported that the data evaluation report for the soil samples has completed the WHC internal review and is currently with WHC technical editing. WHC expects to transmit the report to RL within the next two weeks, and it should be submitted to Ecology in June.

4. New Business

No additional new business was discussed.

5. Set Next Meeting Date

The next meeting is set for June 8, 1994 at 3:00 p.m. in Richland, WA.
