Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The August 9, 1993, Unit Managers' Meeting Minutes were reviewed and signed by the Unit Managers.

2. Status Action Items:

-No Open Action Items

There was no discussion.

3. Status Closure Activities:

-Status NOD Comments (On Schedule)

RL (R. N. Krekel) requested an update for the submittal date for comments on the NOD response table for demolition sites closure plans. RL (R. N. Krekel) recognized that since Ecology has assigned a new unit manager for all the demolition sites, review of the NOD tables may be delayed. Ecology (F. Ma) agreed that additional time would be required to complete an internal Ecology review. Ecology (F. Ma) estimated that transmittal of the reviewed NOD table for HPADS could be completed by September 30, 1993.

WHC (F.A. Ruck) stated that, in order to keep a staggered timetable between the demolition sites review cycle, Ecology could submit the Ash Pit and the 218 E-8 Borrow Pit NOD comments two weeks after Ecology submits the review of the HPADS NOD response table. Both RL (R. N. Krekel) and Ecology (F. Ma) agreed that a staggered timetable should be maintained between the three demolition sites review cycles. Ecology (F. Ma) stated that the review of both the Ash Pit and 218 E-8 Borrow Pit NOD response tables will be completed (and transmitted to RL) by October 14, 1993.

4. New business:

-Open discussion

WHC (D. M. Korematsu-Olund) asked if Ecology had any specific questions pertaining to any of the demolition sites. Ecology (F. Ma) stated that he preferred to write down any questions he had and then give those questions to RL.

-Unit Managers Meetings-

RL (R. N. Krekel) and WHC (F. A. Ruck) stated their views concerning the roles and responsibilities of both RL and Ecology Unit Managers, and the role of WHC as a RL contractor. WHC (F. A. Ruck) stated that RL and WHC had previously given a similar presentation on the roles and responsibilities of Unit Managers to past Ecology monitors. WHC (F. A. Ruck) stated that he would take the responsibility to send a copy of that presentation to the current Ecology monitor.

5. Set new meeting date:

The next Unit Managers Meeting was scheduled for October 12, 1993 8:00-10:00 a.m. Richland, WA.
