The Washington State Department of Ecology (Ecology) received your application for a state waste discharge permit for the 200 East Area W-252 Streams. The permit application was received by the December 1993 deadline established by Consent Order DE 91NM-177. Due to our current workload, Ecology staff have not been able to review the permit application. The permit application is not accepted as complete, pending review by Ecology staff.

Please note that Ecology has issued comments on the Phase II Liquid Effluent Program (Project W-252) Wastewater Engineering Report and BAT/AKART Studies, which includes the 400 Area secondary cooling water.
