Summary of Discussion and Commitments/Agreements

Signing of the Minutes: The minutes from the January 12, 1993, Unit Managers meeting were unavailable at this time. They will be faxed to the Ecology Unit Manager for review.

Status of Action Items: All action items are closed and there were no new action items.

Status of the NOD Response Table Preparation: Ecology (McKinney) stated that they will soon be issuing a letter containing their comments on the RL/WHC responses. This letter will also contain a request that the 105-DR Closure Plan be revised, at which time the 90-day clock for revision will begin.

Status of Reactor Decommissioning EIS: RL/WHC identified that the Final EIS, *Decommissioning of Eight Surplus Reactors at the Hanford Site, Richland, Washington*, was released in December, 1992.

New Business: A discussion of the 116-DR-8 crib associated with the 105-DR reactor and the LSFF revealed a mistake in the NOD responses. The crib will be remediated under CERCLA, not during reactor D&D as stated in the NOD responses. A correction of this oversight will be included in the next responses to NODs.

The next meeting was scheduled for Wednesday, March 10, 1993.
