Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes.

The Ecology Unit Manager indicated that he had received and concurred with the February UMM minutes as presented (FAXed). These UMM minutes were not available for signing by the RL Unit Manager. WHC (Mr. S. N. Luke) indicated that the UMM minutes for December 1993, January 1994 and February 1994 had been verbally approved by Ecology but still needed signature. Ecology (Mr. R. E. Cordts) indicated that he would be in Richland in April and would sign all outstanding UMM meeting minutes at that time.

WHC (Mr. S. N. Luke) reported that RCRA Closures had recently transmitted data evaluation report WHC-SD-EN-TI-242, Rev. 0, 2727-S *Nonradioactive Dangerous Waste Facility Clean Closure Evaluation Report*, to RL for review. Ecology (Mr. R. E. Cordts) asked if the report had been delayed due to a last minute review by WHC toxicologist, Ms. Jan Hulla. WHC (Mr. S. N. Luke) indicated that Ms. Hulla's review and the incorporation of her comments delayed transmittal of the report to RL by approximately one week. However, in the future her review of such reports would be concurrent with other WHC reviews and would not cause delays. The report will be submitted to Ecology after RL concurrence.

- Closure Plan, Revision 3A, Page Changes

WHC (Mr. S. N. Luke) asked if Ecology had received Revision 3A page changes that had recently been re-transmitted by RL. Ecology (Mr. R. E. Cordts) responded that he had received the page changes.

4. New Business:

Ecology (Mr. R. E. Cordts) indicated that he had recently attended the three public hearings for the Hanford site-wide permit. There was no discussion at the meetings regarding the closure units. The audience at

the meetings was informed that the period of comment would end April 11, 1994. Barring unforeseen problems or comments, the permit would be issued in June and after the 30-day instatement period, would become effective in July.

5. Set Next Meeting Date
