

AWARD OF LOCAL ANALYTICAL LABORATORY CONTRACT

The Senior Executive Committee (SEC) Agreement for Tri-Party Agreement Milestone M-14-04 stated that "DOE will exercise best efforts to award a contract by July 1993, which provides sufficient low-level mixed waste commercial laboratory capacity to meet Tri-Party Agreement sampling and analysis requirements." The purpose of this letter is to notify you that DOE has met this commitment.

On July 31, 1993, DOE awarded two contracts for 90 percent of Hanford's low-level mixed waste analytical service requirements. The primary contract was awarded to International Technology Corporation (IT). One secondary award was placed with Lockheed International. A joint venture between Thermo-Analytical, Inc., and Roy F. Weston was selected for the remaining secondary contract, however, award is pending upon completion of a cost audit.
