Dear Mr. Wisness:

After the meeting of May 2, 1991 between members of your staff, Westinghouse Hanford, Kaiser Engineers, Chen-Northern and Gary Anderson and Moses Jarasyi of my staff, we have the following comments on my letter of April 30, 1991.

The letter from Chen-Northern to Kaiser Engineers dated April 18, 1991, is not sufficient to satisfy the requirements of 173-303-650 because it does not say "I Certify". In order to expedite this matter, I am enclosing a certificate that will satisfy the requirements of WAC 173-303-650.

Once this certificate is signed, attach a copy of the Kaiser Engineers Hanford interoffice memorandum dated March 29, 1991 from E.A. Goakey to S.L. Peterson certifying to the structural integrity of the dikes and FAX these to us. Upon receipt of this FAX you are authorized to begin construction of the LERF Pond liners. Original copies of these certificates with cover letter must be received by us no later than May 13, 1991.
