NOTIFICATION OF HANFORD FACILITY RESOURCE CONSERVATION AND RECOVERY ACT PERMIT, CONDITION II.O, GENERAL INSPECTIONS FOR FISCAL YEAR 2009

This letter provides notification of the general inspections to be conducted at the Hanford Facility (HF) during fiscal year 2009. This notification is a requirement of the Hanford Facility Resource Conservation and Recovery Act (RCRA) Permit, Part II, Condition II.O, "General Inspection Requirements." This permit condition requires annual inspections of the 100 Areas, 200 East Area, 200 West Area, 300 Area, 400 Area, and the Columbia River shoreline.


The following table identifies the tentative schedule for the HF RCRA Permit general inspections and is subject to change:

| HANFORD FACILITY AREA TO BE INSPECTED | DATE OF INSPECTION (Tentative) |

| 200 West Area | April 8 and 9, 2009 |
| 100 Areas | May 6 and 7, 2009 |
| 200 East Area | June 3 and 4, 2009 |
| 300 Area | July 7, 2009 |
| 400 Area | August 5, 2009 |
| Columbia River Shoreline | September 2 and 3, 2009 |

The U. S. Department of Energy, Richland Operations Office (DOE-RL) and Fluor Hanford, Inc. (FH), Environmental Regulatory Integration (ERI), will conduct the general inspections with assistance from other DOE organizations and Hanford Site contractors responsible and/or knowledgeable of particular area(s) being inspected. In accordance with HF RCRA Permit, Condition II.O.1.d, FH ERI will notify the State of Washington Department of Ecology by electronic mail "at least seven (7) days" prior to each general inspection to address specific details and/or any changes to the tentative schedule.
