July monthly flow summary:

• Maximum daily flow: 175 gpm

300 AREA TREATED EFFLUENT DISPOSAL FACILITY (310 TEDF)

- 3.80 million gallons of treated effluent was discharged during the month of July
- The average monthly methylene chloride concentration in June was 5.05 ug/l, which exceeds the NPDES permit limit of 5.0 ug/l. Methylene chloride contamination of the lab blank was report in both June samples. The contract lab is taking action to reduce the potential for sample contamination.
- TEDF continues in normal operations.

III Project Specific Issues

A Delisting Petition

Jeannette Hyatt (FH) reported the first draft of the proposed rule was received on July 30, 2002. Reviews of the proposed rule and incorporation of DOE/EPA/FH comments are underway. Meetings with DOE/EPA/FH on August 15, 2002, resulted in establishing a target publication date of December 18, 2002 for the final rule. The target date for publication of the draft rule in the Federal Register is September 30, 2002.

B LERF Groundwater Discussion

1 Fred Jamison (Ecology) reported the groundwater proposal had been received, and that the Ecology response should be ready to go to RL by next week. Grant Baston (RL) added that the monitoring plan is included in the submittal.

C PCB Path Forward

1 There is nothing new to report, efforts are being focused on the RBDA.

D Status of Permit Revisions

Roger Szelmeczka reported that Laura Ruud (Ecology) has requested that the 242-A permit be submitted this quarter in the new format for permits. Due to a shortage of resources, the modification package in process for this quarter may not include the reformatted 242-A permit. Mr. Szelmeczka will work with Kathy Conaway (Ecology).

E Status of 242A Upgrades

1 Proposed evaporator upgrades include HVAC and chiller improvements, removal of ion exchange columns, and replacement of valves and the EC-1 condenser.

IV General Discussions

- A Roger Szelmeczka reported that approximately 75% of Ecology's comments on the draft BAT/AKART report for the Waste Treatment Plant have been received. Most comments appeared to be requests for additional information.
- B Fred Jamison reported Ecology will be looking for a path forward to deal with the purgewater chromium issue. Mr Jamison proposed the program leads get together to discuss strategy, closure and management of the modutanks. He hopes the group can reach agreement on a path forward and jointly recommend a delay in initiating dispute resolution under the TPA. Mr. Jamison asked when the clock started the dispute resolution process, as this needs to be clarified. Ellen Mattlin (RL) indicated the date was September 12. A meeting was scheduled for August 28. If additional time is needed, an extension will be requested at the IAMIT meeting.

- V Status of Actions
 - A 709 action remains open. The proposal was submitted. Ecology plans to respond by 8/30.
 - B 810 action remains open. A meeting was held with Mr Bartus. Workshops are pending completion of the federal register notice.
 - C 816 action was closed. Meeting was held with Mr Bartus on 8/15. Schedule completed.
 - D 823 action remains open. In RL review.

 - A The next Project Managers meeting is scheduled for September 26, 2002
