Dear Brian T. Vance and John R. Eschenberg:

This letter transmits the reopening of the proposed permit modification 8C.2020.3D to Part III, Operating Unit Group 1 (OUG 1), Low-Activity Waste Pretreatment System (LAWPS), to the *Hanford Facility Resource Conservation and Recovery Act Permit, Dangerous Waste Portion, Rev 8C, for the Treatment, Storage, and Disposal of Dangerous Waste* (Site-wide Permit).

The Permittees are the United States Department of Energy-Office of River Protection (USDOE-ORP) as owner/operator and Washington River Protection Solutions as co-operator.

USDOE-ORP held a 60-day public comment period regarding the proposed Class 3 Permit Modification request for the LAWPS OUG 1 from May 1 through June 30, 2019 (Reference 1). USDOE-ORP held a public meeting on May 29, 2019, at the Richland Public Library. The Department of Ecology (Ecology) received four public comment submittals during USDOE-ORP's comment period.

Ecology performed a completeness determination and technical review as required in Washington Administrative Code (WAC) 173-303-840(1)(b) (References 2 and 4) and determined the permit application incomplete. Ecology documented the technical deficiencies, and additional items, through a Response Comment Record. After receiving additional documentation from the Permittees that made the application complete (Reference 3), Ecology worked with the Permittees to resolve the technical deficiencies. The Permittees submitted a revised set of final files on April 16, 2020 (Reference 5) to support the permit modification.

Ecology has determined that this permit application is complete and we have made the following modifications to support the development of the draft permit:

- Added Appendices with supporting design media (specifications, calculations, reports, and engineering drawings).
- Added Unit-Specific Permit Conditions focused on the construction and operation requirements found in WAC 173-303-630, *Use and management of containers* and WAC 173-303-640, *Tank systems*.
- Added two new Interim Compliance Schedule Items, LAWPS-1 and LAWPS-2 to support the long-term disposal of the Ion Exchange Columns and receipt of additional technical details necessary to support operations of the LAWPS OUG.

Ecology issued a Response to Comments document from USDOE-ORP's public comment period. Ecology's Response to Comments document is provided on the enclosed DVD (Ecology Publication 20-05-017) and on Ecology's website at <https://fortress.wa.gov/ecy/publications/SummaryPages/2005017.html>.

WAC 173-303-840(3)(d) requires at least a 45-day public comment period for a draft permit. Ecology held a public comment period from June 22 through August 7, 2020. This comment period initiated the second portion of the Class 3 Permit Modification. A public hearing was not held.

During the 45-day public comment period, Ecology received a comment that required Ecology to update the State Environmental Policy Act (SEPA) documentation necessary to support this modification. The SEPA Determination of Significance and Notice of Adoption was hosted on the SEPA register and a notice was sent to the public listserv on August 24, 2020.

Ecology is reopening the public comment period for the LAWPS OUG 1, for an additional 45 days, to begin September 28 through November 12, 2020, according to WAC 173-303-840(7).

The proposed Class 3 Permit Modification would add the LAWPS OUG 1, to the Site-wide Permit. This permit modification includes the same permit documents as previously provided during the comment period held from June 22 through August 7, 2020. The proposed modification (8C.2020.3D) provides design and construction details for the LAWPS OUG 1 and the associated SEPA decision documents.
