This form documents agreement among the parties listed below authorizing classification of the subject unit as rejected, closed-out, or no action and authorizing backfill of the site, if appropriate. Final removal from the NPL of no action or closed-out sites will occur at a future date.

**Description of current waste site condition:**

A small amount of chemicals were disposed of in this area, the exact location is not visually obvious. The chemicals disposed were highly volatile and the incident took place approximately 20 years ago. Therefore it is highly unlikely that anything remains. CERCLA reportable quantities are listed at 40 CFR 302, in Table 302.4. The RQ for toluene is 1000 lbs. There is no RQ listing for paint.

The reported disposal at 200-E-10 was 25 gallons (twice) = 50 gallons, or about 400 pounds. Conservatively estimating the paint as 100% toluene, the disposal was less than the CERCLA RQ. Therefore, the release was not (is not) a threat to human health and the environment
