RESOLUTION NO. 97-05

- WHEREAS, the members of the Natural Resource Trustee Council (NRTC) are governments acting on behalf of their constituencies; and
- WHEREAS, information on NRTC activities, positions, and representation should be readily available to our constituents; and
- WHEREAS, an internet web site is a cost-effective, paperless, low-maintenance, and readily available source of information; and
- WHEREAS, the Department of Ecology is equipped to offer the NRTC space for an internet web site on its server without conditions on content or format; and
- WHEREAS, an internet web site will require on-going periodic updates and maintenance; and
- WHEREAS, it would be burdensome for the full NRTC to review and approve all content and each change to the web site; NOW, THEREFORE BE IT
- RESOLVED that, the NRTC shall post an internet web site on the Department of Ecology's server to be maintained by an Ecology appointed web master. The web page shall be limited to issues that fall within the purview of the NRTC and reflect the consensus policy and decisions of the NRTC. An NRTC Web Committee shall oversee the content of the web page, provide periodic updates to the full council, and, as the web committee deems appropriate, forward content and changes to the full council for approval. A list of the Web Committee members is attached. It shall be the responsibility of the NRTC, committees, working groups, and individual members to provide to the web committee chair, items for inclusion in the web site, changes, or deletions. It shall also be the responsibility of the NRTC, committees, working groups, and individual members to periodically review the web site for content and forward any concerns to the committee chair.




