

PURPOSE OF VISIT: Inspection of 204-AR Railcar Unloading Facility



SUMMARY OF VISIT: Mr. Robert Wilson of the Washington State Department of Ecology visited the 204-AR Railcar Unloading Facility on August 3-4, 1994 for the purpose of a RCRA inspection. The inspection began in the Control Room of the 204-AR facility. Mr. Cliff Myers, plant engineer, escorted the group into the mezzanine inside the unloading room. He explained the operation of the flexible lines for both the tanker trailers and tank cars, and the rigid jumpers used with the flexible lines. The group then proceeded downstairs to the unloading bay, where the floor drain system, catch tank, and sump were explained in detail by Mr. Myers. Mr. Wilson had questions on the floor integrity, where several areas of floor sealant were missing, due to tape removal. Mr. Wilson thought this might allow a possible release to the environment. The group was then shown the exhaust system, catch tank, sump, and sump leak detectors. The inner doors were also opened and the vestibule was inspected for the location of radioactive mixed waste satellite accumulation areas. The group then broke for a brief lunch at 272-AW, and then resumed with personnel interviews and document review.

Ms. Amy Basche, Tank Farm training coordinator, assisted with the Tank Farms Dangerous Waste Training Plan inquiries. Several personnel training files were taken from Soft Reporting and examined for compliance with the latest revision of the training plan.

The Tank Farms Contingency Plan was then reviewed and found to be too "fragmented". Dave Rowland, Tank Farms Emergency Preparedness engineer, explained that the contingency plan was being revised and will not be out
