




- T Plant Covered Drum Storage Structure
 - A Statement of Work (SOW) has been drafted to establish the requirements for installation of a covered storage structure over a portion of the paved shipping/receiving area at the west corner of the T Plant Complex. Construction is estimated/desired to begin on October 1.
