Enclosed are four copies of the subject FS for the U.S. Department of Energy-Headquarters (HQ) review and comment. Following approval by the Richland Operations Office (RL), the 200-BP-1 FS Report is scheduled to be submitted by June 30, 1993, to the U.S. Environmental Protection Agency and the State of Washington Department of Ecology as a primary document, per Hanford Federal Facility Agreement and Consent Order Interim Milestone M-15-02D.

To facilitate the review of this document and future documents, and to fully implement Schedule Optimization Study (SOS) recommendations, RL requests that HQ's comments be differentiated between those requiring formal responses versus non-substantive (e.g., editorial) requiring no formal responses. In the event that editorial comments are provided, their dispositions will not be formally provided but rather be incorporated into the final editing which will be completed prior to formal transmittal for the regulatory review. It is important to note that this practice will save considerable time and resources as discussed in the SOS.

RL requests that all comments must be received no later than May 21, 1993, due to the short turnaround time available to disposition comments and finalize the draft report. Comments received in advance of this date would be greatly appreciated.
