The November 21, 1994 Unit Manager Meeting minutes were approved.

2. Closure Plan Review Status

Ms. G. Davis (Ecology) stated that she had completed her review of the closure plan.

3. Closure Plan Notice of Deficiency Table Review

Ms. Davis stated that she had a question pertaining to notice of deficiency (NOD) No. 7, and noted that the revised NOD was included in Section 6.2.2.3 of the closure plan instead of Section 6.3.2.4, which had been previously agreed to by Ecology, PNL and RL. Ms. Davis stated the revision made to section 6.2.2.3 was inadvertently placed in 6.6.2.4., but the change was still acceptable to Ecology as written. Ecology, PNL and RL agreed to correct the situation by documenting the change in the administrative record indicating Ecology accepted the revised NOD being included in a different section of the closure plan.

Ms. Davis also pointed out that Ecology took duplicate samples during sampling, and that Section B-6, page B-8 of the closure plan states that Ecology took split samples. Ecology, PNL and RL agreed that the evaluation report will address the correction to the closure plan.

Ms. Davis stated that she is drafting a letter to PNL and RL accepting the closure plan.

4. Hanford Facility Permit Incorporation Schedule

Ms. Davis stated that the public comment period is due to start January 17, 1995. A public hearing, followed by a public meeting, is scheduled for February 1, 1995. Mr. S. Jones (GSSC) recommended that PNL, RL and Ecology be prepared at the next Unit Managers Meeting to discuss potential questions that might be posed during the public meeting, and it was agreed to hold a working meeting following the January 1995 Unit Managers Meeting to discuss potential questions.

5. SHLWS Legacy Equipment Removal Status

Ms. Davis inquired about the results of the rinsate. Mr. B. Day (PNL) responded that the results indicated the rinsate was clean. Mr. W. Slater (PNL) stated that the rinsate will be removed as soon as approval is received from PNL's environmental compliance. Ms. J. Julya (PNL) stated that two barrels of plastic remained. Mr. Slater noted that one barrel contains the protective clothing used during decontamination, which is to be disposed of as hazardous material. Ms. J. Bartz (GSSC) pointed out that the rinsate data results were non-dangerous, and if the soil sampling analytical results are non-dangerous, then the barrels do not need to be disposed of as hazardous material. Ms. Davis stated that she would write a permit condition to allow PNL to evaluate whether the barrels will be disposed of as dangerous or solid waste.

6. Soil Sampling and Analytical Status

- TPA Validated Data Delivery Schedule

Ms. E. Mattlin (RL) stated that the Tri-Party Agreement (TPA) states that validated data is to be provided to the regulators within 86 days of sampling. Ms. Mattlin noted that in chapter 9 of the TPA it indicates that a schedule other than that specified can be agreed to by DOE and the lead regulatory agency. Mr. Slater stated that PNL would review the status of the data validation to determine by the next Unit Managers Meeting if the schedule required by the TPA will be met.

7. General Discussion

Ms. Davis initiated a discussion regarding the administrative record. Ms. Davis stated that after January 17, 1995, no records can be added to the administrative record, other than changes related to the Hanford Facility Permit. Ms. Davis indicated she planned to obtain a print-out from the administrative record. Ecology and PNL agreed to review their files and the administrative record print-out in an effort to ensure the administrative record is complete.
