



<p>DOE/RL-2005-15, Section 2.1.8, Ancillary Facility Demolition (page 2-4), paragraph 2 states, "For structures with basements, tunnels, vaults, etc., the equipment and piping will be removed and the below-grade walls will be left in place, as well as the below-grade slab and foundation." Change to read, "Except as noted in the PFP Complex End Point Criteria (NMS-16404 Revision 0), for structures with basements, tunnels, vaults, etc., the equipment and piping will be removed and the below-grade walls will be left in place, as well as the below-grade slab and foundation."</p>

Justification and Impacts of Change:			
<p>PFP Complex End Point Criteria (NMS-16404 Revision 0), completed in accordance with TPA milestone M-83-20, states in section XVII, (Facilities Checklist) item 3., "Cleanout or remove equipment, piping, ducting etc. from accessible below-grade spaces such that the remaining equipment, piping, ducting etc. could be dispositioned as low-level waste as part of the building rubble during the final remediation of the PFP zone. And, if needed, satisfy the end state criteria for the Central Plateau. This criteria applies to 234-5Z Tunnels, 241-Z Cells, 241-ZRB Valve Room, 291-Z, 216-Z-9 Control Room, and 243-ZA Tank Pit."</p> <p>DOE/RL-2005-15 needs to be consistent with the PFP End Point Criteria (NMS-16404 Revision 0). This will allow, in specified structures, for equipment, piping, ducting etc. to remain in below-grade spaces during near term demolition activities until final remediation of the PFP Zone.</p>
