- 1) Approval December 7, 2021 Meeting Minutes (Ecology/PNSO/PNNL)
- 2) Discussion Items:
 - a) 325 HWTUs Quarterly Permit Modifications (PNSO/PNNL)
 There may be an upcoming 325 BEP modification, but no modifications currently in progress.
 - b) Hanford RCRA Permit Revision 9 Development (Ecology/PNSO/PNNL)
 - Status of CAPs
 The Process CAP workshops are still in progress. The Preparedness and Prevention major themes workshops have not yet been scheduled,
 Ecology took an action to check on the status of the workshops.
 - Status of Closure Addendum
 PNNL sent a proposed Sampling and Analysis Plan for the 3714 Pad to
 Ecology 2/7/22. Minor changes will be needed to the closure addendum
 based on the SAP (the closure schedule, etc.). Ecology stated that in
 addition to a review of the SAP, they will need to review the closure
 matrix to ensure all items are addressed.
 - In an effort to accelerate schedule, PNNL proposed that work on the WAP red-line could begin prior to reaching agreement on all deficiency matrix items. This would allow proposed resolutions to be presented and reviewed in context of the rest of the document, rather than an abstract proposed solution in the matrix.

 PNNL and Ecology agreed that the upcoming workshop will be used to discuss an outline for the WAP. There are a few matrix items that PNNL disagrees with, and these will be identified as well.
 - Status of Preparedness and Prevention Addendum
 PNNL asked if work on the red-line could begin prior to Major Themes being resolved. Ecology stated that Peparedness and Prevention major

themes workshops still needed to be scheduled and took an action to check with the Rev 9 permit team on the status of scheduling those workshops.

• Schedule Change Requests

O April 2022 completion status
PNNL has heard that some units had received extensions to the April
2022 schedule, and asked why this didn't include the 325 HWTUs
unit group given the likelihood that this date will not be met.
Ecology stated that decisions were being made between Stephanie
Schleif and her DOE counterparts based on negative float. The
325HWTUs unit group has just shown up on the top 10 units with
negative float, and Ecology anticipates discussions will now occur
regarding schedule. For now, we should be looking for ways to
accelerate and meet the April 2022 schedule until we hear otherwise.
Ecology will address potential schedule changes, or lack thereof, as

the date approaches.

From December 2021 thru January 2022, 26 containers of nonradioactive hazardous waste from the 300 Area were shipped to Clean Harbors. There were no mixed waste shipments during this period

A summary table of the volumes and waste types for each shipment is attached to these meeting minutes.

Ecology asked about the status of the COVID related delayed return manifest issue that was discussed at the December 2021 PMM. PNNL stated that Clean Harbors is directing most shipments to its Utah facility, which is helping to resolve a majority of the late manifests. Some shipments still need to go to the Texas facility, and Clean Harbors is still having issues with returning manifests within 45 days for these shipments.

Ecology asked if there was any waste in storage over a year. PNNL stated that there is some mixed waste in storage exceeding a year at quantities similar to previous years. There is no nonradioactive hazardous waste exceeding a year.

Ecology stated they hope to have a new project manager for the 325HWTUs unit group on board by early March.
