

1.0 GENERAL

CH2M Hill Plateau Remediation Company (CHPRC) Sample Delivery Group H4455 was composed of sixteen water samples designated under SAF No. X11-005 with a Project Designation of: IU2 IU6DURA, OCTOBER 2010.

The samples were received as stated on the chain-of-custody documents. Any discrepancies are noted on the Eberline Analytical Sample Receipt Checklist.

2.0 ANALYSIS NOTES

2.1 Radium-228 Analysis

The MDA of the QC Blank (6.57 pCi/L) exceeded the RDL of 3.0 pCi/L. The results for both the original and duplicate analyses were less than their respective MDA's, therefore no RPD, or statistical control limit is calculated. No other problems were encountered during the course of the analyses.

3.0 Case Narrative Certification Statement

- * The SAS (Special Analytical Services) Number is a client or lab assigned code that reflects special processing for samples, such as rapid turn around. Counts of tests done are lists by SAS number since it is likely to affect prices.
