Re: Department of Ecology (Ecology) Approval of the United States Department of Energy-Office of River Protection (USDOE-ORP) Request for a 30-Day Extension for the Allowable Accumulation Period for three Containers CON-20-021-04, CON-20-055-08, and CON-19-269-02.

Dear Brian T.Vance and John R. Eschenberg:

Ecology reviewed your email received on May 5, 2020, requesting an extension for the allowable accumulation period for Containers CON-20-021-04, CON-20-055-08, and CON-19-269-02. Your extension request described unforeseen, temporary, and uncontrollable circumstances due to the associated COVID-19 pandemic causing response actions to temporarily remove resources for transporting dangerous waste from the 200 East RMA 190 location to an offsite treatment, storage, and disposal facility. Per Washington Administrative Code (WAC) 173-303-200(2)(a)(i), Ecology grants your request for a 30-day extension to the 90-day accumulation period for the three items listed below. The 30-day extension expires on the following dates:

- Container CON-20-021-04 – June 20, 2020
- Container CON-20-055-08 – July 2, 2020
- Container CON-19-269-02 – July 4, 2020
