





- I. Approval of August 28, 2003 WESF Project Meeting Minutes (Ecology/DOE-RL/FH)
- II. Operational Status (Fen Simmons FH)
 - The operational status is unchanged. There are no drums on the pad.
- III. Project Specific Issues
 - A. Part B Permit Application status
 1. Jeanette Hyatt (FH) opened the discussion regarding what approach to take with the Part B since the project is now on hold (see item 3B). Ecology originally agreed to not require a Part B to move the capsules into storage and to allow the project to proceed under a modified Part A. The parties agreed to hold internal discussions and schedule a workshop in January 2004 to discuss a path forward.
 - B. Cs/Sr project status
 1. Ken Hladek (FH) reported that there is no funding identified for the cesium/strontium dry storage project for FY 2004, and the project is on hold.
 - C. M-092-01 status
 1. Fen Simmons noted that M-092-01 is the upgrades milestone associated with the capsules kept in wet storage until 2018. The milestone due date is 12/30/09. Jeanette Hyatt stated that if there is any information that allows expediting the schedule, it will be provided to Ecology before the January 2004 workshop.
- IV. General Discussions
 - A. Status of Applicable Milestones
 1. There was no discussion of applicable milestones.
- V. Status of Actions (report attached)
 - A. 930 - The parties agreed that the status of this action will remain on hold indefinitely because there is no current funding for the dry storage project.
 - B. 933 - This action was discussed under item 3C.
- VI. New Action Items
 - A. A new action was established to discuss options regarding the Part B permit application. Fen Simmons will coordinate the discussions on the Part B.
