The Washington State Department of Ecology (Ecology) issued a letter to you regarding the referenced subject on May 12, 1993. Basically, this letter granted an extension to milestone M-03-05 of the Hanford Federal Facility Agreement and Consent Order (Agreement) until September 30, 1993, under the provisions of Article XL of the Agreement.

As you know, Ecology is the lead regulatory agency regarding this milestone. However, as the support agency, we must concur with Ecology's decision on the extension request. The purpose of this letter is to provide the necessary concurrence to Ecology's May 12, 1993 determination.

In order to comply with the process defined by the Agreement, we should complete a change request form as we would for any other extension request. Both Ecology's May 12 letter and this letter should be either referenced or attached to the approved change request form.
