Extension for the Temporary Suspension of Article XXXIII, Notification Requirements

DETERMINATION:

Reference IAMIT Determination 2020-003, Temporary Suspension of Article XXXIII, Notification Requirements, approved April 13, 2020.

The Hanford Federal Facility Agreement and Consent Order (Tri-Party Agreement) Legal Agreement, Part Five, Common Provisions, Article XXXIII, Notification, states that documents sent between the U.S. Department of Energy (DOE), Washington State Department of Ecology (Ecology), and the U.S. Environmental Protection Agency (EPA), hereafter referred to as the Parties, will be sent by certified or overnight express mail, or hand delivered. With the inability for personnel to process or hand-deliver documents during the current health situation (Coronavirus), the Parties have agreed to extend the temporary suspension of these requirements from May 25, 2020 to July 31, 2020 (10 weeks).

The Parties agree this 10-week extension is warranted to allow email of documents in lieu of the Article XXXIII requirements. The Parties agree that the receipt date will be the date and time that a document is received. Documents shall be sent to the applicable agency(ies) as follows:

- DOE: via email at TPADOE@rl.doe.gov.
- Ecology: via email at NWPmail@ecy.wa.gov.
- EPA: via email to the designated project manager or manager.

The Parties also agree that during this 10-week suspension, the Parties may use electronic signatures for transmittal or approval of these documents.

After 10 weeks, this agreement will be revisited to determine if another extension is warranted.
