

Key Documents/Issues List Review

ORP reported that the “other” work plans for the TX, U and SX Farms were submitted in December 2012, and the documents are in Ecology review. The TX Farm Sampling and Analysis Plan (SAP) is due for submittal to Ecology in March 2013. ORP noted that there are several SST Integrity Program target milestones listed as to be missed, and a draft TPA change package is being prepared. ORP indicated that the majority of Ecology’s comments have been incorporated into the change package, and it is being finalized for submittal to Ecology. The change package will be a Class 2 change package because there are a couple of interim milestone dates for M-045-91F and M-045-91G that will also be moved.

DOE-RL noted the 100-D, H and F target milestones that were completed with submittals in December 2012. The 100-BC work plan and SAP are on schedule for submittal at the end of January 2013. The 200-UP-1 RD/RAWP, due in June 2013, has been included on the key documents list for tracking purposes. The Draft A RI/FS reports and Proposed Plan for 100-N is to be submitted in June 2013, in accordance with the milestone change, pending approval following the public comment period. DOE-RL noted that WA-1 will be included in the next key documents list.

2013 State of the Site Meetings

EPA requested this agenda topic for discussion. EPA stated that it is supportive of scheduling state of the site meetings for 2013. Ecology stated it was more than willing to hold the meetings, noting the only issue is providing financial support in terms of meeting rooms. DOE-RL agreed to holding the meetings, and stated that it has had discussions with ORP. DOE-RL and ORP are in the process of determining the format for the meetings. EPA suggested that the public involvement officers (PIOs), who are responsible for responding to questions and comments, attend the IAMIT meetings. DOE-RL indicated agreement with having the PIOs attend the IAMIT, and will take the suggestion to its PIO.

Electronic Distribution of Documents

DOE-RL stated that it has taken the initiative to transmit all documents electronically by the end of 2013, and the process is under way. EPA noted that it receives hard copies of all the cleanup verification reports, and only one copy is needed. EPA added that it receives some Ecology documents that are not needed. EPA stated that only the transmittal letter is needed for ORP documents. Ecology stated that while going through recent ORP letters, the reports could not be located in the Administrative Record (AR). ORP stated that most of the Consent Decree correspondence cc’s the AR, and a list of new items entered into the AR is provided at the

monthly project managers meeting (PMM). Ecology indicated that receipt of two hard copies of documents that are submitted to the AR are sufficient.
