

The 300 Area Process Trenches proposed modifications incorporate, by reference, the 300 Area Process Trenches Groundwater Monitoring Plan, PNNL-13645. Currently, this plan is being implemented under a temporary authorization from Ecology. The reissued temporary authorization is effective from **June 10 to December 9, 2002**. **Ecology does not modify final status permits to include temporary authorizations.**

Ecology will respond to comments received during the public comment period by December 9, 2002. However, if the trial results from the new statistical approach for groundwater monitoring are not available for Ecology's evaluation prior to December 9, 2002, the temporary authorization will be denied and United States Department of Energy (USDOE) will be required to follow the existing permit conditions for the 300 Area Process Trenches. Once the trial results are available and Ecology's evaluation is complete, Ecology will notify USDOE as to whether or not the proposed plan is acceptable. If it is acceptable, the permit may be modified in accordance with the permit modification requirements described in Washington Administrative Code (WAC) 173-303. Additionally, Ecology hereby denies any previous pending Part A revisions for these units.

Again, USDOE and contractor staff are encouraged to discuss proposed Class 1 changes with Ecology's Unit Managers to clarify any questions or concerns. If you have any questions or comments regarding this letter, please contact me at (509) 736-5715 or Jean Vanni at (509) 736-3046.




Inspection of groundwater monitoring wells will be conducted pursuant to Permit Condition II.F and carried out under internal procedure BHI-EE-01 (BHI 1995) or equivalent guidance. This procedure calls for a surface inspection of a well at each sampling event. The procedure also calls for a subsurface inspection of the well at a minimum of every 3 to 5 years. This routine subsurface inspection may consist of pulling and inspecting the pump, brushing the inner walls of the casing and screen, and conducting a down-hole television survey.
