

I am in the process of reviewing the Sampling and Analysis Plans submitted to satisfy Milestone M-17-12 of the Hanford Federal Facility Agreement and Consent Order. The sites I would like to see prior to February 14, 1992 are as follows:

1. PUREX Chemical Sewer;
2. Plutonium Finishing Plant Wastewater;

4. 242-s Evaporator Stream Condensate.


