



  - Total gallons of purgewater received at the PSTF (Modu Tanks) in July = 15,610.

  - A. Milestone M-20-21-T01 Status
    1. Ellen Mattlin (RL) reported she has not met with Laura Ruud (Ecology). With Ms. Ruud's resignation, it is not known who will be assuming this scope of work.

    1. Briant Charboneau, the new RL project manager, was introduced and briefed on the strategy document and closure plan. During the Purgewater Project Manager Meeting Held August 29, 2002 at the Kennewick Ecology Office, four closure schedule items in Ecology's Voluntary Compliance Letter dated August 2, 2002 were discussed.

Under Item #1, there were four items that need to be accomplished before the last shipment date of purgewater into the 600 Area Purgewater Storage and Treatment Facility (PSTF) can be established:

- Revise the Purgewater strategy "Strategy for Handling and Disposing of Purgewater at the Hanford Site, Washington, July 1990.
- Revise the Investigative Derived Waste (IDW) strategy
- Ecology approval of a delay in closure request
- Operational issues to address solids and unloading at the 200 Area Effluent Treatment Facility (ETF)

Ecology is in the process of revising the "Strategy for Handling and Disposing of Purgewater at the Hanford Site, Washington, July 1990" (Purgewater Strategy). The revised Purgewater Strategy specifies: "Purgewater containing constituents in excess of the collection criteria.....will be collected for management at ETF or stored in the 600 Area Purgewater Storage and Treatment Unit east of the 200 East Area. Availability of the 600 Area Purgewater Storage and Treatment unit will be phased out after the closure decision for this RCRA Treatment, Storage, and Disposal (TSD) unit is made in FY 2003."

The language cited from the revised purgewater strategy was verbally agreed to by the Tri-Parties. The intent during the drafting of the revised purgewater strategy was for the 600 Area Purgewater Storage and Treatment unit to stop receipt of purgewater and begin closure activities.

Language in the 1990 Purgewater Strategy, which is currently in effect, requires "Purgewater containing constituents in excess of the collection criteria will be collected and stored in ModuTanks located in the 600 area immediately east of the 200 east area."

Recommendation: Given these inconsistencies in the existing requirements for the management of purgewater, and the time frame for closure decision for the 600 Area Purgewater Storage and Treatment unit, Ecology is recommending a closure plan be drafted with closure activities linked to issuance of the draft Purgewater Strategy for Tri-Party Agency review.
