


I. The June 28, 2012, T Plant Complex, LLBG, CWC and WRAP Project Managers Meeting (PMM) minutes were reviewed and approved by RL; Ecology approved the June 28, 2012, PMM minutes during today's meeting.

II. Operational Status

A. Lee Tuott (CHPRC) provided the operational status. The layup activities in WRAP should be completed within two weeks. The floor remediation activities around the area where the one drum leaked in 2404-WB continue as personnel are available. Deborah Singleton (Ecology) asked where the waste from the floor remediation will be placed. Mr. Tuott stated that the waste will be placed in 2404-WC, and the intent is to eventually move it over to CWC. Mike Collins (RL) stated that at T Plant, the remaining items to remove are in 2706-T and consist of a fume hood and a few other items. There are also a couple of drums that need the transportation safety documentation in place before removal. Ms. Singleton asked if the goal is to remove the last containers from WRAP and T Plant. Mr. Collins responded that for T Plant, a drum of transuranic (TRU) waste will remain in the bone yard, and there are three or four containers that will not be moved out. Mr. Collins added that everything will be moved out of WRAP, except for the PFP glovebox. Lee Fearon (Ecology) asked if all of the waste being moved out of T Plant and WRAP is going to CWC. Mr. Collins responded that it will all go to CWC.

Ms. Singleton asked when RL and Ecology would be having discussion regarding all of the boxes stored outside at CWC. Mr. Collins responded that discussions would not be held until the compliance issue is resolved. Ms. Singleton noted that following the last walk-through at CWC, Ecology is considering the possibility of partially alleviating the issue regarding the storage of some of the boxes outside by moving them inside buildings. Mr. Collins stated that some of the boxes could be moved inside, but it would not be a large number due to fire protection requirements since about 150 of the approximately 170 boxes are plywood boxes. Ms. Singleton noted that her question regarding storage of the boxes is an effort to be prepared to provide a response to the compliance group that all of the options have been considered for the boxes and why the options can or cannot be done. Mr. Collins stated that if funding were available, 90 percent of the boxes would be sent to Permafix Northwest. Al Cawrse (CHPRC) noted that RL/CHPRC will be providing comments to Rev. 9 of the Hanford sitewide permit regarding the storage of the boxes.

V. Near Term Schedules and Ongoing Activities

A. TSD Units Permit Status

- T Plant Tank Inspection Proposed Language

Ms. Singleton stated that a review was done to determine whether there was a regulatory pathway to allow RL/CHPRC to implement its proposed tank inspection, and at this time Ecology is not in a position to reduce the tank inspections. Ms. Singleton added that after the Revision 9 Hanford sitewide permit is issued, the project team will review the regulations in an effort to make some changes to be more efficient. Jennie Seaver (CHPRC) noted that language for the proposed tank inspections is included in the draft Revision 9. The parties agreed to provide a status next month.

- Ms. Singleton asked about the format for RL/CHPRC's submittal of comments on the T Plant, LLBG, WRAP and CWC (SWOC units) permits. Ms. Seaver provided an explanation for how the comments will be submitted to Ecology on the RCR forms. Ms. Seaver added that all of RL/CHPRC's comments will be submitted with recommended text. There was a brief discussion regarding the extent of RL's involvement in assisting Ecology with comment resolution. Ms. Singleton stated that an internal discussion is under way with upper management and legal regarding the process for communication with RL about comment resolution. Ms. Singleton noted that there will be comments that Ecology will not be able to respond to without RL/CHPRC's assistance, and internal management and legal have been made aware of those circumstances.

B. LLBG Groundwater Sampling

Mr. Collins stated that there was no groundwater sampling conducted in the last month.

VI. Approved Changes Signed off in Accordance with TPA Section 12.2

A. There were no approved changes signed.

VII. General Discussion

A. Joel Williams (CHPRC) stated that preparations are in place for the Ecology tour of the SWOC units that will be conducted tomorrow (July 27, 2012). CWC will be the main focus, and due to time constraints (Ecology requested completion of the tour by 1:00 pm), the tour for WRAP, T Plant and WRAP will not be as extensive. Mr. Williams noted that there will be personnel onsite to answer general questions, but any specific questions relating to the philosophy of the permit or permit conditions are requested to be written in an e-mail to RL.
