Topic: 100 Area Feasibility Study Phases 1 and 2

Background

Assumptions necessary to include outfall pipes and saturated sediments (associated with the Columbia river) in the 100 Area Feasibility Study Phases 1 and 2 document were developed by the three parties on February 18, 1993. DOE provided these meeting minutes to the regulators on March 18, 1993 for regulator review. The regulators provided review comments on the meeting minutes to DOE on March 31, 1993.

Agreements

When the meeting minutes are revised as per the regulators' comments, they will serve as concurrence by the three parties to a set of assumptions for use in the revision of the 100 Area Feasibility Study Phases 1 and 2 document.

The regulators, who assisted with the development of these assumptions and who ultimately approve primary documents such as this, will support the assumptions as adequate to allow completion of the river sediment/outfall pipe portion of the document.

DOE agrees to provide an informal transmittal of the revised meeting minutes to the regulators by April 28, 1993. DOE also agrees to formally transmit the revised meeting minutes, under cover letter, on or about May 5, 1993.

DOE agrees to begin incorporation of the assumptions for identification and screening of remedial alternatives for outfall pipes and saturated sediments into the document on or about May 5, 1993. The next version of the document will fully address these media as per the assumptions in the revised meeting minutes.
