STATEMENT OF NO CHANGE TO THE SINGLE-SHELL TANK (SST) SYSTEM
DANGEROUS WASTE PERMIT (DWP) APPLICATION PART A FORM REVISION 13

Reference: Ecology letter from J. J. Wallace to S. J. Olinger, ORP, and W. J. Johnson, WRPS,
"Conditional Approval of the 'Single-Shell Tank System,' Revision 11,
January 30, 2009, Dangerous Waste Permit Application Part A Form," dated
April 7, 2009.

This letter notifies the Washington State Department of Ecology (Ecology) that the
U.S. Department of Energy, Office of River Protection (ORP) is not aware at this time of any
changes that are needed to the SST System DWP Application Part A Form, Revision 13.
Submittal of this notification or a revision to the SST Part A is required by the Reference by
March 1 of each year.

The ORP recognizes that efforts are ongoing with Ecology to resolve potential discrepancies
between the Hanford Federal Facility Agreement and Consent Order Action Plan, Appendices B
and C and the SST Part A, Revision 13. Should this effort result in changes to the SST Part A,
Revision 13, these changes will be included in the next annual revision.


