Change Title Interim Milestones for 200-CW-5 Operable Unit Assessment Activities (M-15-40)		
Description/Justification of Change The 200 Areas RI/FS Implementation Plan (DOE/RL-98-28, Rev.0) established the framework for characterization of ER soil waste sites (approximately 700) in the 200 Areas and grouped the waste sites into 23 process-based operable units. Based on the Implementation Plan, Tri-Party Agreement M-13 milestones were established (TPA change number M-13-97-01) for the submittal of RI/FS work plans for individual operable units. Milestone M-13-22 has been met by the submittal of Draft A work plan for the 200-CW-5 U Pond/Z-Ditches Cooling Water Group Operable Unit. As identified in Section 11.6 of the Action Plan to the Tri-Party Agreement, work plans must specify interim milestones for the operable units. The 200-CW-5 Operable Unit work plan includes a project schedule with target project milestones. Based on the work plan schedule, the following interim milestones are added to the Tri-Party Agreement to implement additional activities for the 200-CW-5 Operable Unit Remedial Investigation/Feasibility Study process: <ul style="list-style-type: none"> • M-15-40A: Complete U Pond/Z-Ditches Cooling Water Group Field Work through Sample Collection and Analysis – September 30, 2002 • M-15-40B: Submit Draft A U Pond/Z-Ditches Cooling Water Group Remedial Investigation Report – May 31, 2003 • M-15-40C: Submit Draft A U Pond/Z-Ditches Cooling Water Group Feasibility Study and Submit Draft A U Pond/Z-Ditches Cooling Water Group Proposed Plan – October 31, 2004. These interim milestone dates are consistent with the major milestone M-15-00C to complete all 200 Area pre-ROD site investigations under approved work plan schedules by 2008.
