Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes (Ecology/RL/EPA/WHC):

The June 22, 1994, Unit Managers' Meeting Minutes were reviewed and signed by the Unit Managers'.

2. Status Action Items:

- 4-20-94:1

Status unchanged.

3. Status Closure Activities:

While discussing the Sampling and Analysis Plan (SAP), Ecology (F. Ma) requested that the location for some of the samples designated within Closure Area #2 sampling site be changed. WHC (D. Korematsu-Olund) agreed to have graphics change the sampling locations and have WHC (R. K. Bhatia) finalize the changes with Ecology. These changes are incorporated into attachment #5. Ecology (F. Ma) stated that Ecology will accept the SAP when these changes to sample location are incorporated. RL (R. N. Krekel) stated that once RL receive Ecology's written acceptance of the SAP the 120 day revision cycle for HPADS closure plan would start.

4. New business:

- Emergency Detonation at Hanford Patrol Academy Site.

RL (R. N. Krekel) understood that Ecology had some concern about the emergency detonation planned for the Hanford Patrol Academy Site. Ecology (F. Ma) wanted to know why WHC decided to use the closure site for an emergency detonation. WHC (M. R. Romsos) stated that Battelle Pacific Northwest Laboratories had discovered some old outdated organic chemicals that posed a safety hazard. A letter issued to Ecology on July 12, 1994 erroneously identified HPADS as the emergency detonation site. The letter should have identified the Hanford Patrol Academy Site (not the RCRA Treatment Storage and Disposal site) as the emergency detonation site. Ecology (F. Ma) asked if there were some regulatory restrictions or approval process for this type of treatment. RL (E. D. Macalister) believed that Ecology was concern with not only this emergency detonation at the Hanford Patrol Academy Site but future detonations at Hanford.

RL (R. N. Krekel) asked if there were already an agreement between RL and Ecology or a written procedure for emergency detonations. WHC (M. R. Romsos) agreed to look for any prior agreement or arrangement between other agencies and local, state agencies. RL (E. D. Macalister) stated that further discussion with Ecology on this matter needed to be set up outside the UMM forum. RL would arrange for an additional meeting on emergency detonations.

5. Set new meeting date:

The next Unit Managers Meeting was scheduled for 8:00 AM on August 16, 1994.


