**Correction**

The U.S. Department of Energy has requested the 340B Waste Loadout Building stack be included in the building removals proposed by this comment period. Please see Pages 1-3 (Table 1-1), 2-11, 4-9, 4-17, and A-9 (Table A-3) of the Engineering Evaluation/Cost Analysis #3 (EE/CA #3) for the 300 Area for a description of the 340B Waste Loadout facility. Corrections have been made to the focus sheet and website to reflect the addition of this facility to the comment period. Ecology proposes extending the current public comment period to include time for review of the removal of this facility, in addition to the original ten facilities, from the Hanford Site Air Operating Permit.

**Changes to the original announcement are underlined and bolded:**

The Washington State Department of Ecology seeks your input on a significant modification to the Hanford Site Air Operating Permit (AOP).

The proposed changes will remove **eleven** 300 Area facilities on the Hanford Site from the AOP.

These facilities are currently permitted by **18** radionuclide, toxic, or criteria air pollutant permits within the AOP. As facility operations and the need for AOP permitting end, the AOP would no longer regulate the emissions from the facilities. It is proposed that the buildings will undergo deactivation, decontamination, decommissioning, and demolition (D4). Emissions and monitoring associated with the D4 activities will be regulated under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA).

The facilities to be removed from the AOP are identified as Buildings 318, 320, 323, 325, 326, 329, 331, 340, **340B**, 3730, and MO-423. These buildings, respectively, are the laboratories for Radiological Calibrations, Physical Sciences, Mechanical Properties, Radiochemical Processing, Material Science, Chemical Sciences, and Life Sciences, in addition to the Waste Neutralization, **Waste Loadout**, Gamma Irradiation, and Radiological Counting facilities.

Ecology will submit a draft permit modification for public comment. The permit holder is the U.S. Department of Energy - Richland Operations Office, PO Box 550, Richland, WA 99352. The public comment period will run from August 28 through **October 13, 2006**.

### **How will the Hanford Site Air Operating Permit change?**

The permit modification will remove requirements for monitoring and control of radioactive, toxic, and criteria air pollutant emissions at Buildings 318, 320, 323, 325, 326, 329, 331, 340, **340B**, 3730, and MO-423 from the AOP as the new removal action work plan for 300 Area facilities begins to regulate air emissions under CERCLA authority.

The work plan will involve D4 of the buildings, their stacks, and related facilities. The removal action work plan will provide an air monitoring plan that establishes monitoring and control requirements under CERCLA guidelines. The plan will include applicable, reasonable, and appropriate requirements for monitoring and control of contamination and releases for the buildings during D4 activities.

### **How do I view related documents?**

During the comment period, the affected portions of the AOP and the supporting CERCLA approval documents are available for public review Monday - Friday, 9 a.m. - 12 p.m. and 1 p.m. - 4 p.m., at the Department of Ecology, Nuclear Waste Program Library, 3100 Port of Benton Blvd., Richland, Washington.
