In a letter from the United States Department of Energy, Richland Operations Office USDOE-RL to the Washington State Department of Ecology (Ecology) dated December 12, 2001 (Reference 2), USDOE-RL formally requested a permit modification and temporary authorization. The request was for implementation of Class 2 permit modifications to allow implementation of a new statistical approach for groundwater monitoring data evaluation to determine whether contaminant concentrations are decreasing with time. In a letter dated February 6, 2002 (Reference 1), Ecology granted the temporary authorization for 180 days in accordance with Washington Administrative Code (WAC) 173-303-830(4)(e). The temporary authorization is effective until June 9, 2002.

Ecology is re-issuing the temporary authorization for an additional 180 days. The reissued temporary authorization is effective from **June 10 to December 9, 2002**. Ecology has determined that the reissued temporary authorization involving a Class 2 permit modification request is warranted to allow the authorized activities of WAC 173-303-830 to continue. The proposed Class 2 modifications will go out for public notice



beginning on **May 20** and ending on **July 25th**. After the public comment period concludes, Ecology will notify USDOE of whether or not the modification has been approved.

Once the permit modification forms are approved, the final permit modification will replace the temporary authorization. At this point, the permit modification will be complete.
