The work plan contains the elements of a Comprehensive Environmental Response, Compensation, and Liability Act Remedial Investigation/Feasibility Study work plan and Resource Conservation and Recovery Act Treatment, Storage, and/or Disposal unit sampling plan. A sampling and analysis plan and waste control plan accompany the work plan as appendices. Transmittal of this work plan satisfies the Tri-Party Agreement Milestone M-13-21 for submittal of the 200-CS-1 Chemical Sewer Group Work Plan to the State of Washington Department of Ecology by August 31, 1999.




