

This letter transmits the subject work plan and addendum for the State of Washington Department of Ecology (Ecology) review and comment. This work plan and addendum is being prepared in support of draft Tri-Party Agreement Milestone M-015-69, Submit RI/FS Work Plan for the 100-HR-1, 100-HR-2, 100-HR-3, 100-DR-1, and 100-DR-2 Operable Units for Groundwater and Soil. Although this milestone is draft, the U.S. Department of Energy, Richland Operations Office (RL) is submitting it in anticipation of approval of Tri-Party Agreement Change Number, M-16-08-07, New and Accelerated Groundwater and Columbia River Protection Hanford Federal Facility Agreement and Consent Order Milestones.

This work plan is required under the Comprehensive Environmental Response, Compensation, and Liability Act. The purpose of this document is to describe the Decision Unit (DU) setting and establish the objectives, tasks, and schedule for conducting an integrated groundwater and soil RI/FS process for the 100-D/H Area DU. Please provide comments on the Draft A version to RL within 60 days of receipt of this letter.
