SURVEILLANCE AND MAINTENANCE PLAN FOR THE PLUTONIUM FINISHING

The U.S. Department of Energy Richland Operations Office (RL) is transmitting the Surveillance and Maintenance Plan for the Plutonium Finishing Plant Complex, DOE/RL-2011-59, Revision 0, to the Washington State Department of Ecology (Ecology) for approval. 
