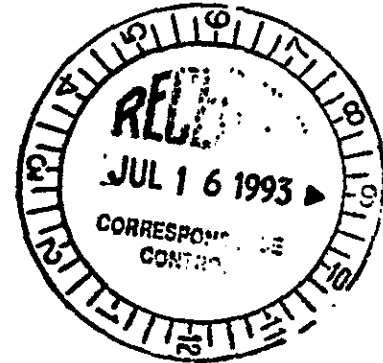

SITE EVALUATION REPORT, ENVIRONMENTAL RESTORATION STORAGE AND DISPOSAL FACILITY (ER-SDF [WHC-SD-EN-009])
