
DECISION / DETERMINATION / ACTION ITEM: (Note the assignee and due date)

The TPA agencies (Parties) are currently in dispute at the IAMIT level with regard to TPA change control forms M-47-15-01, M-90-15-01, and M-62-14-02 regarding TPA milestones M-047-07, M-090-13 and M-062-45. .

On August 18, 2016, the IAMIT determined that the above-mentioned disputes would be resolved by entering into TPA negotiations regarding the M-047-07, M-090-13 and M-062-45 milestones. Negotiations on the items identified in the M-062-45 milestone will begin no later than September 8, 2016 and conclude by April 30, 2018 (six months after the issuance of System Plan Rev 8).

The Parties further agree to cooperate in providing periodic briefings to the State of Oregon, affected Tribes, the Hanford Advisory Board and other stakeholders that the Parties agree to brief.

The Parties agree that following successful conclusion of the negotiations that are documented in a signed Tentative Agreement, including TPA change control forms, the Parties will perform an appropriate public comment period in accordance with the Public Involvement Plan.
