



1.0 Administrative Items

The list of attendees for the October 29, 2013, Lifecycle Report Project Managers Meeting (PMM) is provided in Attachment A. Any action items that were discussed during the PMM are included in Attachment B. Any items that were agreed to be entered in the Administrative Record are included in Attachment C.

Approval of Previous Meeting Minutes:

Meeting minutes from the July 8, 2013, PMM were signed by the M-036-01 Project Managers; Stephen Korenkiewicz from RL, Melinda Brown from Ecology, and Dennis Faulk from EPA (for David Einan).

Upcoming Meetings:

EPA requested that the issue of performing alternative analyses for the 2015 Lifecycle Report be reviewed at the next Interagency Management Integration Team (IAMIT) meeting scheduled for November 21, 2013¹. A working meeting will be scheduled in early December 2013 to plan follow-on actions based on the IAMIT decision¹. The next TPA PMM will be scheduled for the second week of January 2014.

2.0 Review of Lifecycle Report Status

Status of the 2014 Lifecycle Report

The Draft 2014 Lifecycle Report was delivered to RL on August 19, 2013, for internal review. RL has been working to incorporate the FY14 Project Management Baseline (PMB) into the planning case data so that the report has the most recent cost information. Also new this year is a foreword from the RL and ORP Managers to provide highlights and perspective on the Hanford Site cleanup mission.

Status of the 2015 Lifecycle Report

The issue of whether the 2015 Lifecycle Report should include an alternatives analysis was discussed¹. Ecology advocated for proceeding with alternative analyses for two future cleanup actions: Deep Vadose Zone (200-DV-1 Operable Unit [OU]) and 200 East Groundwater (200-PO-1 and 200-BP-5 OUs), noting that protection of groundwater is a top priority for Ecology. EPA disagreed that using resources to prepare detailed upper bound cost estimates for these future cleanup actions was beneficial, noting that the DOE planning case estimate presented in each Lifecycle Report is adequate to describe the cost of compliance. In addition,

feasibility studies and proposed plans for these cleanup actions are due in 2015, so including similar analyses in the 2015 Lifecycle Report (due January 31, 2015) has questionable benefits.

EPA requested that the issue of whether the 2015 Lifecycle Report should include an alternatives analysis be reviewed by the IAMIT at their next meeting scheduled for November 21, 2013.

Administrative Record and Public Feedback

Public feedback on the Lifecycle Reports is posted on www.hanford.gov; however, not all are included in the Administrative Record. Ken Moser will check with the DOE Legal Department about placing comments from the State of Oregon and EPA into the Administrative Record (the Lifecycle Report is not a decision document).

4.0 Addendum

On November 1, 2013, Ecology withdrew their request to include an alternatives analysis in the 2015 Lifecycle Report. This removed the need to bring the issue before the IAMIT on November 21, 2013, or to schedule a working meeting in early December 2013.
