Hi Teri -

Tom O'Brien, Tom Zeilman and I talked yesterday afternoon regarding the tolling agreement agenda item. We feel the Council needs clarity on many issues relating to the statute of limitations and how these issues may affect Council decision-making. The Council should have a strategy for moving forward on tolling agreements. I suggest 30 minutes minimum.

The Administrative Committee has specific proposals for making the Council meetings more efficient. I'll be sending out a copy of the proposal soon for your review and consideration. In order to discuss the various ideas for change and hopefully make some decisions we'll need 90 minutes.

Jay and I suggest we also need more time for Hanford 2012. This proposal has major implications for natural resource issues, including data collection for ecological risk assessments, possible NRDA's, long-term stewardship, and the budget. This proposal provides an excellent opportunity for the Council to work with the Tri-parties and other stakeholders early in decision-making. I suggest 90 minutes.

Jay, Lauri and I suggest that in light of the concerns raised by the state and the Nez Perce regarding the proposed mitigation at Tapteal Greenway the trustees time might be better spent discussing the above issues rather than than having the field trip.
