



Enclosed are six (6) cultural resources reviews completed by the U.S. Department of Energy, Richland Operations Office (RL) that will require archaeological monitoring. In accordance with 36 CFR 800.4, the RL has made a good faith effort to identify historic properties at these proposed locations and to evaluate the eligibility of these properties to the National Register of Historic Places (Register).

A literature and records review and site surveys, where required, have indicated that four of the projects involve maintenance and new construction in disturbed, high-sensitivity areas. The project areas contain no known historic properties on the surface, but the potential for buried archaeological deposits exists because of their proximity to the Columbia River. Therefore, monitoring by staff archaeologists and/or Tribal representatives is required.

The 105-C Reactor project (HCRC #97-100-001); identifies the 105-C Reactor as a contributing property to the Hanford Site Historic District. However, as stated in Appendix C: Table 2 of the Programmatic Agreement (PA), no additional documentation is required. Therefore, the effect to the property is not considered adverse. The review also indicates the project area has undergone extensive surface and subsurface disturbance during installation of the facilities. The project will require occasional monitoring to field verify the ground disturbance documented in historic photographs taken during initial construction of the 105-C Reactor Complex.

Also, the Initial Cultural Resources Evaluation of the 300 Area Steam Plant Replacement (HCRC #96-300-053) is enclosed for your information. An Environmental Assessment of the project, as part of the NEPA process, is currently underway. The evaluation identifies 17 historic structures that will be affected by addition of the gas boiler system, as currently proposed. Upon finalization of project plans, survey coverage of all areas subject to impacts will be verified and any unsurveyed areas will be inventoried.
