**RECORDED NOTICE IN DEED TO THE 300 AREA PROCESS TRENCHES**

This letter serves to certify that the Notice in Deed for the 300 Area Process Trenches has been recorded with the Benton County Auditor in accordance with Washington Administrative Code 173-303-610(10). Provided for your information, please find a copy of the Notarized Notice in Deed (Attachment 1) and a copy of the recording fee Receipt # 10577 from the Benton County Auditor (Attachment 2). The notice is required to be recorded within 60 days of certification of closure, and will in perpetuity notify any potential purchaser of the property that the land had previously been used to manage dangerous waste. The notice also describes land use restrictions and identifies that a survey plat has been filed indicating the type, location and quantity of dangerous waste deposited in the trenches. The deed was recorded under File Number 1998-025988.
