

# 2.0 Review of Lifecycle Report Status

#### 2011 and 2012 Lifecycle Reports Feedback

A Tri-Party Agency meeting was held May 17, 2012 to review all written feedback including that from EPA (May 8, 2012) and Ecology (April 13, 2012) on the 2012 Lifecycle Report. Follow-on feedback discussion was held with Ecology on May 29, 2012. These meetings completed the review process and identified planned changes for the 2013 Lifecycle Report.

#### 2013 Lifecycle Report Preparation

The 2013 Lifecycle Report is being developed at this time. A list of planned changes for the 2013 Lifecycle Report was reviewed. The list will be updated as additional changes are made.

#### 3.0 Action Items

The Tri-Party Agencies reviewed the Action Tracking List and determined that all actions have been completed. No new action items were identified.

# 4.0 Agreements

Assumptions will be added to Section 4.4 of the 2013 Lifecycle Report that Natural Resource Damages Assessment (NRDA) studies and litigation will not significantly affect cost or schedule. The report does not include scope or cost for activities to resolve any NRDA liability at this time.

The next PMM to be held in October 2012 (one week before the October 18, 2012, TPA Quarterly Performance Review meeting) will review major changes to costs (from the 2012 Lifecycle Report) and the alternatives analysis schedule for FY 2014 and beyond.
