- I. Approval of July 24, 2008 Purgewater Project Meeting Minutes (Ecology/DOE-RL/FH). The PMM minutes were approved. The August 2008 PMM was canceled.

Doug Hildebrand (RL) stated that a discussion between RL and the new contractor regarding the modutank is needed, and that Mr. Winterhalder should continue internal discussions.
 - Tony Miskho (FH) reported that FH's review of the draft closure plan is complete, and it is in RL review. Currently the plan is to close modutank No. 1. A decision regarding the path forward for closure of modutank No. 2 is dependent on the modutank replacement location.
