The USDOE submitted the LDR Summary Report on April 28, 2006, as a primary document according to the Hanford Facility Agreement and Consent Order (Tri-Party Agreement), Milestone M-26-01P. The Department of Ecology provided comments on the 2005 LDR Summary Report and received your responses on July 20, 2006. These responses reflect comment resolution agreed to during recent Tri-Party Agreement LDR Project Manager Meetings.

Ecology approves the USDOE's CY 2005 LDR Summary Report as noted on the enclosed approval page. We believe the use of this year's reporting format was successful and the submittal of a Summary Report should be continued. We also believe the full LDR Report contains valuable information that should be available to Ecology and the public.

We request that USDOE submit a TPA change package to modify Milestone M-26 to include additional annual submittals of the LDR summary report. The full LDR report should be submitted every five years. The next full LDR report should be submitted in calendar year 2010. Regardless of the report format being prepared, we expect the data collection process to remain the same. Any information normally available from the full LDR report should be collected yearly and available upon request.






